BY-LAW NO. 3

A BY-LAW RESPECTING THE COMPOSITION OF THE COUNCIL AND THE REMUNERATION OF THE MAYOR AND COUNCIL FOR Municipality of Lakeland Ridges

PURPOSE: A By-law of Municipality of Lakeland Ridges, in the Province of New Brunswick, for the purpose of establishing the composition, remuneration and expenses of the council for Municipality of Lakeland Ridges.

WHEREAS: The Minister of Local Government and Local Governance Reform may make or amend by-laws of a restructured local government as per An Act Respecting Local Governance Reform, section 11(2);

WHEREAS: The enactment of this by-law repeals the following by-law(s);

By-law #95-01 Respecting the Composition of the council and Remuneration of the mayor and council for the Village of Canterbury

By-law # for the Village of Meductic

BE IT ENACTED by the Minister of Local Government and Local Governance Reform as follows:

1. COUNCIL COMPOSITION:

The council consists of:

- 1.01 a mayor, and
- 1.02 4 wards with 2 councillors elected from each for a total of 8

2. REMUNERATION OF THE COUNCIL

- 2.01 The mayor shall be paid an annual salary of \$12,500; the amount being payable in quarterly instalments (March, June, September, December). However, if the mayor is absent from a regular council meeting without being excused with reasonable cause, the clerk shall deduct two hundred and fifty dollars (\$250) from their salary.
- 2.02 The deputy mayor shall be paid an annual salary of $\frac{56,250}{1}$; the amounts being payable in quarterly instalments (March, June, September, December). However, if the deputy mayor is absent from a regular council meeting without being excused with reasonable cause, the clerk shall deduct two hundred and fifty dollars (\$250) from their salary.
- 2.03 Each councillor shall be paid an annual salary of \$5,000, the amounts being payable in quarterly instalments (March, June, September, December). However, if a councillor is absent

from a regular council meeting without being excused with reasonable cause, the clerk shall deduct two hundred and fifty dollars (\$250) from their salary.
