1. CALL TO ORDER: Mayor Foster called the regular meeting to order at 7:01 pm

# 2. APPROVAL OF AGENDA:

## 4. ADOPTION OF MINUTES:

## 5. <u>UNFINISHED BUSINESS/BUSINESS ARISING FROM THE MINUTES:</u>

**a) Meductic Septic-** Council discussed the two options suggested by the engineer. Option A was a holding tank in the current location. Option B was an on-site septic treatment system that would need to be installed on DTI owned property.

**MOTION:** It was moved by Councillor Yerxa and seconded by Councillor Porter to go with option B and install an on-site septic treatment system as long as we are able to get the land usage approval from DTI.

Yay - six votes. Nay - Councillor Buckingham Abstained from vote due to conflict of interest - Councillor Stairs

**b)** Hill Street Repair – requires ditching and possible culvert replacement or repair. Based on the procurement policy the job could be awarded to vendor of choice. Council felt it would be best to get a few more quotes and suggested putting out an RFQ.

**MOTION:** It was moved by Councillor Buckingham and seconded by Councillor Porter to put out a "Request for Quotation" for ditching and culvert work on Hill Street in Canterbury.

# 6. PUBLIC INPUT/INQUIRES/PRESENTATIONS:

- a) Barb Glanville Presentation on the importance of protecting our lakes. She requested that more signage be posted between the river in Meductic, which is a major contributor to the problem, and along route 122 heading towards the lakes. Barb also recommended that another boat wash station be set up in Canterbury.
- b) Susan Olmstead Susan was not present but another member of the seniors club was in attendance and said that they have resolved the issue and no longer needed to address council.
- c) Phillip Grant Phillip brought his concerns regarding unsightly premises back before council for a second time. He asked if council had made any progress with the by-law since his last presentation? Mayor Foster explained that council was working to get a by-law enacted but that there were other steps that have to be put into place first.
- d) Debec Deputy Fire Chief Chris Foster Chris explained the large-scale exercise that is being conducted on November 9 at Sabian. All four Lakeland Ridges Fire Departments, Irving Oil, EMO and other near by Fire Departments will be participating. It was suggested that council be involved. Chris also suggested that council and staff consider taking the ICS 100 course and asked Susie to forward the link to all. There is a Table Top meeting scheduled for next Tuesday in Meductic to discuss the event.
- e) Greg Grant Greg addressed council with concerns regarding the closure of the current office building and moving everything into the Meductic Community Centre. He asked if there was a study done, if the pubic was questioned or notified and who was the driving force behind the move? After a bit of back-and-forth conversation, Mayor Foster thanked Mr. Grant for his presentation and said that council would be discussing the issue further as it is an item already listed on the agenda.
